

**TAX LEVY ORDINANCE**

**ROAD DISTRICT**

**ORDINANCE NO. 11-07**

An ordinance levying taxes for all road purposes for Elgin Township Road District Kane County, Illinois, for the tax year 2011 , collectable in 2012.

BE IT ORDAINED by the Board of Trustees of Elgin Township, Kane County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Elgin Township Road District on December, 2011 does hereby determine and declare that the sum of One Million Three Hundred FourtyTwo Thousand Eight Hundred Twenty Eight & 00/100 Dollars(\$1,342,828.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and , equalized in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
